# A Scheme to facilitate transportation of Dead Bodies

\*\*\*\*

#### A. Objective of the Scheme:

Objective of the scheme 'Mahaprayan' is to provide specifically designed Dead Body Carrier (DBC) services at Government Hospitals on "free of cost basis" to make it convenient for the family members of the deceased to carry the dead body of their near and dear ones back home (within the district of death) or to the cremation/ burial ground (within the district of death) for the last rites due to deaths occurring in public health facilities.

### B. Operational Guidelines:

- The scheme is to be implemented through the District Red Cross Society under the overall supervision of the Collector.
- 2. A District Mahaprayan Committee shall be constituted at each district comprising of the following members:
- a. Collector & District Magistrate Chairperson
- b. CDM & PHO Member
- c. Superintendent / Director (in case of Medical College & Hospitals / RGH, Rourkela / Capital Hospital, Bhubaneswar) Member
- d. RTO Member
- e. DSWO Member
- f. DLO Member
- g. ADMO (Medical) Member
- h. Deputy Collector (Red Cross) Member Convenor
- The DBC shall be provisioned to provide services for deaths occurring in all public health institutions of the State. The DBC may be deployed to serve a particular facility or a cluster of facilities as decided by the District Mahaprayan Committee.
- 4. a) The DBC will transport the dead body from a public health institution to either the residence of the deceased within the district of death or to any cremation / burial ground within the district of death as per the request of the family members of the deceased.
